

POOL RULES

1. Guests are not permitted to use the pool/spa facilities without the presence of the homeowner with the property pool/spa key & tag. Exception is made in the case of a live-in house-guest or tenant who will be accorded the same privileges as the homeowner.
2. Children under 14 years of age shall not be permitted to use the pool without an adult 18 years or older in attendance to supervise their activities.
3. For health reasons, children under the age of fourteen (14) are not permitted to use the spa.
4. All persons using the pool/spa must abide by the posted rules.
5. Water games and horseplay in the pool/spa and surrounding areas is prohibited.
6. No glassware, bottles, or breakable containers shall be permitted in and around the pool/spa area. All beverages must be consumed out of cardboard, plastic or paper cups. No alcoholic beverages are permitted in the pool/spa areas.
7. Pet(s) (of any kind) are not permitted in the pool/spa areas.
8. Pool/spa gates shall be kept locked at all times.
9. Users of the pool/spa areas shall be responsible for removal of trash and all articles brought thereto by them or by their guests.
10. The pool and spa equipment rooms are OFF LIMITS to all persons, except pool service employees and said Homeowners Association Pool Committee.
11. No one group will be allowed to monopolize the pool or spa in any manner that does not respect the rights of other residents.
12. All trash, etc., must be deposited in the proper receptacles. *NO SMOKING IS PERMITTED IN POOL/SPA AREAS.*
13. There is no reserving of chairs or lounges. Any chair unoccupied in excess of 30 minutes shall be considered available for use by any resident.
14. Owners may utilize their own chairs or lounges, if all others are filled; however, they must remove their furniture when they leave the pool/spa areas.
15. Swim-suits must be worn by persons in the water. No cut-offs or street clothing will be allowed in the pool/spas. No skinny dipping!

16. Pool and Spa Hours: Sunday through Thursday: 8:00 a.m. - 10:00 p.m.
 Friday, Saturday and Evenings
 Before a Holiday: 8:00 a.m. - midnight
17. You may be asked to show your key and tag and to identify yourself while at the pool/spa area. This is done for the security of all homeowners. Your cooperation and understanding will be greatly appreciated.
18. The Board of Directors reserves the right to amend the rules as they see fit, as well as revoke the rights of any person not abiding by the rules.
19. A total of five (5) guests per household may accompany a resident to the pool/spa area.
20. Resident's reserving the clubhouse are not reserving the pool/spa area.
21. Any damage to the pool/spa area and/or bathrooms should be reported to the Management Company immediately.
